## CHECKLIST FOR COUNTY ROAD LEASE

### Cover Letter

- RE: the tract to be leased.
- Provide any additional details regarding the lease application.
- Contact information for applicant or applicant's representative (name, phone, and email).
- Address for the GLO to use when mailing the executed lease.

### County Road Lease Application Form

"Exhibit A" describing the area being leased and citing the source deed reference information (this will be attached to and made part of the executed lease).

Plat showing boundaries and dimensions of the county road. The GLO will use this plat to identify the tract on GIS maps and prepare an "Exhibit B" plat for attachment to the lease.

Executed "Affidavit of Highest Consideration Paid" (can be found on the GLO website or by clicking the hyperlink).

Executed "Waivers of Preferential Right to Lease" (if necessary). Mineral owners adjacent to a county road have a preferential right to lease the county road for oil and gas. If applicant does not control the minerals or leasehold adjacent to the road, the waiver must be obtained.

Copies of all source deeds for the county road showing volume and page of document.

List of adjacent leases (on a spreadsheet) with the following information: Lessee; Lessor; Lease Date; Term of Lease; Extension Term (if applicable); Royalty Rate; County; Volume; and Page. (Copies of leases are not necessary).

List of assignments of adjacent leases (on a spreadsheet) with the following information: Assignor; Assignee; Lessor of Assigned Lease; Date of Assignment; County; Volume; and Page. (Copies of assignments are not necessary).

County Bonus Form and County Bonus submitted to county.

Receipt of Bonus Payment paid to the County (Receipt will be provided by the County).

Sales Fee of 1.5% of bonus amount payable to: Commissioner of Texas General Land Office.

Processing Fee of \$500.00 payable to: Commissioner of Texas General Land Office.
