THURSDAY, THE FOURTH DAY OF THE MONTH.

The board of Land Commissioners, met agreeable to law.  
—Present: JOHN BOYD, President; MARTIN D. WHITE and JOHN H. McRAE, As-  
sistant Commissioners, DO certify that *Thomas H H Forsyth*

*— appd —* appeared, took and subscribed to the oath pre-  
scribed by law, as a resident citizen of Texas; *M D White*

*John H Collins* — — — appeared as witnesses,  
who after being duly sworn say upon their oaths, that the said *Thomas*

*H H Forsyth* was a resident citizen of Texas at the date of  
the Declaration of Independence, and that he has continued to be so to this day, and

that he was a *single* man at that time ~~and the head of a family~~; the said  
*H H Forsyth married in 1838* emigrated to Texas in the

year *1835* which entitles him to receive one ~~third of a League~~ of land  
in said Republic. *y*
