Recommendation: Staff recommends adoption of the resolution.

2026 marks the Semiquincentennial 250th Anniversary of the Founding of the United States of America in 1776. Both Congress and the President have formally asked for the recognition of the 250th anniversary of the country. This led to the creation of a national commission and federal initiatives, as well as prompting action at the state level.

On January 29, 2025, President Trump issued Executive Order 14189, "Celebrating America's 250th Birthday," which explicitly encourages federal, state, and local governments, as well as citizens, to participate in the anniversary celebration.

To carry out the president's vision, the executive order created the White House Task Force on Celebrating America's 250th Birthday (Task Force 250). Federal initiatives include plans for a "Great American State Fair" and a video series titled "The Story of America".

In 2016, Congress established the U.S. Semiquincentennial Commission. In early 2025, bipartisan legislation was introduced in Congress to authorize a joint session of Congress to be held in Philadelphia in July 2026.

In 2026 the VLB will celebrate its 80th anniversary having served Veterans for 32% of the nation's history. The VLB supports those who conduct our national defense, and it is fitting for the Board to honor the 250th anniversary of the United States and the Veterans who contribute to its defense.



A Resolution Commemorating the Semiquincentennial 250th Anniversary of the Founding of the United States of America

WHEREAS, July 4, 2026, marks the 250th anniversary of the adoption of the Declaration of Independence by the Second Continental Congress in Philadelphia in 1776, signifying the founding of the United States of America; and

WHEREAS, the Declaration of Independence proclaimed timeless principles of profound significance to the national heritage of the United States, including that all are created equal and endowed with certain inalienable rights, including life, liberty, and the pursuit of happiness, and that governments derive their just powers from the consent of the governed; and

WHEREAS, the founding of the United States established the principle of federalism, emphasizing a decentralized system of government wherein powers are divided between national and state governments, fostering liberty, accountability, and responsiveness to local communities; and

WHEREAS, this decentralized governance model has allowed for innovation, diverse policy approaches, and stronger accountability to the citizens of each state, ensuring that government remains close to and reflective of the people's will; and

WHEREAS, the State of Texas and the Texas Veterans Land Board has played a significant role throughout the history of the United States, contributing to the nation's development, culture, economy, and defense through the efforts and sacrifices of its citizens and support of veterans; and

WHEREAS, the Semiquincentennial offers a unique opportunity for the people of Texas to reflect on our shared history, honor the diverse contributions of all Americans, celebrate our heritage of liberty, and look forward to the future we strive to create for subsequent generations; and

WHEREAS, commemorative activities across Texas will provide educational opportunities, foster civic engagement, encourage community participation, and strengthen appreciation for the history, federalist principles, and foundational ideals upon which both the nation and our state were built;

NOW, THEREFORE, BE IT RESOLVED BY THE VETERANS LAND BOARD OF THE STATE OF TEXAS:

We hereby recognize and commemorate the upcoming 250th Anniversary of the founding of the United States of America on July 4, 2026; and

BE IT FURTHER RESOLVED, that we encourage all citizens and veterans to participate in commemorative events and activities that reflect on our history, celebrate our achievements, and reaffirm our commitment to the ideals of liberty, equality, self-government, and federalism.

Recommendation: This agenda item requires no action from the Board.

Prior Board Meeting Item Updates

In August 2025, VLB issued \$181,135,000 of State of Texas Veterans Bonds, Taxable Refunding Series 2025C. In conjunction with the bond issuance, a new floating-to-fixed rate swap was entered into that was the first with the counterparty.

In August, VLB sold 71 mortgages to Gateway First Bank, with proceeds totaling \$24.8 million.

Currently, there are two liquidity agreements that expire in November that are in the process of being renewed and are expected to be finalized by October 30.

<u>Loan Demand – Housing</u>

In 1983, the Legislature created the VLB Veterans Housing Assistance Program to assist Texas Veterans and Military Members in purchasing a home. Through this program, eligible Texas Veterans and Military Members have an opportunity to purchase a home with a low-interest loan with little or no money down.

Consumer demand for home loans was higher in the fourth quarter of the fiscal year compared to the previous year. In September, the Federal Reserve reduced the benchmark interest rate by 25 basis points (0.25%) and mortgage rates decreased for a few weeks but increased from those lows. Demand for FY2025 Q4 averaged \$46.8 million per month and increased 29.13% from FY2025 Q4 versus FY2024 Q4.

In FY2025, VLB purchased 956 loans totaling \$385.2 million with an average loan size of \$402,900.

Since 2018, VLB loans have been made in 180 of 254 Texas Counties.

<u>Loan Demand – Home Improvement</u>

VLB offers qualified veterans or military members loans to help pay for home repairs or upgrades through the Texas Veterans Home Improvement Program (VHIP). This program was introduced in 1986 and provides the same below-market interest rate as the housing loans. The program demand has been steadily declining over the last four years.

For FY2025 Q4, VLB issued 24 loans under the VHIP totaling \$548,810, which was a 17.69% decrease in loan value from FY 2024 Q4.

In FY2025, VLB issued 101 loans totaling \$2.4 million with an average loan size of \$23,600.

Housing and Home Improvement Loan Interest Rate Setting Process

VLB's current weekly rate setting process revolves around setting a "base" rate that is 15-150 basis points (0.15% to 1.50%) below the benchmark. Eligible borrowers with a service-connected disability rating of 30% or higher are then allowed a 50-basis point (0.50%) reduction to the "base" rate. FY2025 Q4 base/discounted rates averaged 6.12%/5.62% while FY2024 Q4 base/discounted rates averaged 5.77%/5.41%.

Since FY 2018 nearly 88% of VLB Home Loan borrowers qualified for the discounted interest rate and 45% of borrowers were first time homebuyers. Through FY 2025 Q4, 94% of borrowers qualified for the discounted rate and 48% of all borrowers were first time homebuyers.

Loan Demand – Land

The VLB Veterans Land Loan Program is the only one of its kind in the nation. It provides Texas Veterans and Military Members with the opportunity to borrow money to purchase land at favorable interest rates and terms while only requiring a minimum 5% down payment.

Demand for land loans is lower than a year ago but remains consistent with historical program levels.

In FY2025, VLB originated 708 land loans totaling \$76.9 million with an average loan size of \$108,600.

The current loan rate for the land program is 7.25%.






Loans Funded (\$)




Number of Loans Funded



LOAN PORTFOLIO - FY 2025




LOAN PORTFOLIO - FY 2024




Fiscal Year 2025 Q4 - Loan Summary Report











Subject: Agenda Item 8 e - Consideration and possible action on delegation of authority to the Executive Secretary to raise home loan maximum amount to match the Veterans Administration (VA) and Federal Housing Finance Agency (FHFA) limits.

RECOMMENDATION: Staff is recommending that the limit in the Veterans' Housing Assistance Program (VHAP) be increased from its current maximum of \$806,500 to the maximum amount allowable for a similar home mortgage loan through the United States Department of Veterans Affairs (VA) and the Federal Housing Finance Agency (FHFA) beginning with rate locks issued on and after January 1, 2026, or whatever date the VA increases their maximum allowable mortgage loan amount.

BACKGROUND: As shown in the table below, the loan limit in the VHAP has increased several times from its original \$20,000 amount to today's current limit of \$806,500.

The increase in 1999 from \$45,000 to \$150,000 followed the passage of legislation that amended Chapter 162, Texas Natural Resources Code, to provide that the Board's maximum loan amount could not exceed the "maximum amount allowable for a similar home mortgage loan through the United States Department of Veterans Affairs (VA)". Effective January 1, 2020, the VA, in accordance with the "Blue Water Navy Vietnam Act" removed their maximum loan limit for a home mortgage loan. VA home loan limits are the same as the Federal Housing Finance Agency (FHFA) limits. These are called conforming loan limits.

The Federal Housing Finance Agency (FHFA) establishes their conforming loan limits on an annual basis, by comparing year-over-year home price changes. FHFA compares third-quarter home prices from the previous year to third-quarter prices for the current year to set next year's loan limits, which go into effect on January 1 of each year. To calculate the conforming loan limits for 2026, FHFA needs the house pricing data through September 2025. This quarterly data will not be released until late November. However, based on preliminary data, the conforming loan limit may increase from \$806,500 in 2025 to \$819,000 for 2026.

Subject: Agenda Item 8 f – Recognition of top lenders and loan officers for the 2025

Veterans Housing Assistance Loan Program.

In 1983, the Texas Legislature created the Veterans Housing Assistance Program (VHAP) to assist Texas veterans in purchasing a home. The Texas voters overwhelmingly approved a constitutional amendment authorizing the issuance of bonds to fund this program. Since its inception, more than 100,000 Texas Veterans have taken advantage of this self-supporting program without costing taxpayers a single penny. The program is funded by issuing bonds authorized by the voters; the bonds, as well as the cost of administering the program, are paid for by the veterans who participate in the program.

Currently, the Veterans Housing Assistance Program allows Veterans to borrow a maximum of \$806,500 to purchase a primary residence typically at a lower than market interest rate. Loans are originated by Participating Lenders and must meet applicable Agency (Fannie Mae/Federal Housing Administration/Veterans Administration) guidelines and VLB guidelines.

Eligible Lender Participants include banks, trust companies, savings banks, national banking associations, mortgage bankers, mortgage companies, mortgage brokers, credit unions, or other financial institutions that have as a primary business purpose in the origination and/or servicing of mortgages of single-family residential housing. There are three basic types of Lender Participants in the Texas Veterans Land Board Program; Primary Lender Participant, Participant Servicer and a Correspondent Lender Participant.

In addition, Lender Participants:

- Must demonstrate a proven ability to originate and/or service Texas Veterans Land Board loans and employ staff with adequate knowledge and experience with the Program.
- Must meet criteria established by the Board for participation in the Program, including maintenance of minimum net worth standards.
- Must maintain management and quality control systems to evaluate the overall quality of its loan production and/or servicing activities.

For Fiscal Year 2025, 956 loans were purchased by the VLB and a total of \$385,207,754.16 was funded.

Subject: Agenda item 9 a - Report on Texas State Veteran Cemetery operations.

Recommendation: This agenda item requires no action from the Board.

U.S. Veterans Affairs (VA) Developments:

- The Coastal Bend State Veterans Cemetery expansion project (TX-23-33) is complete. A National Cemetery Administration Project Manager will conduct a walk through during the Fall.
- The West Texas State Veterans Cemetery in Lubbock, construction project (TX-23-34), is on schedule and on budget. There are a significant number of pre-registrations which are indicative of public interest. The opening date is 12 Dec 2025 with the first interment that same day. The Texas Department of Transportation has completed the deceleration lane for east-bound traffic. Construction photos are provided below.
- The VA expansion grant opportunity for the Central Texas State Veterans Cemetery in Killeen (TX-23-35) has been approved by the National Cemetery Administration and work will commence soon on this \$16.5 million expansion. A ground-breaking ceremony is scheduled for this Thursday, 30 October 25 at 11:00 am at the cemetery committal shelter.
- While awaiting the land donation to complete in east Texas, opportunity was taken to submit a
 grant application to the National Cemetery Administration which you approved at our last
 Board meeting. To develop and submit the \$16.32 million budget requirement, an initial
 design concept was developed, and a picture is available below. It is not anticipated to be
 funded in FY 26 but will remain on the priority list for funding in FY 27. An initial concept
 picture is below.
- The FY 25 National Cemetery Administration State, Tribal or Territorial Veterans Cemeteries Satisfaction Survey was just released. In FY 23, we were proud to score a 99.03% and a 99.11% in FY 24. In FY 25, we went up again to an incredible 99.28%! We will be presenting certificates of appreciation at city council meetings in December and presenting plaques to the staff at all cemeteries. We thank the staffs at the cemeteries for their hard work in taking care of our Veterans and their families. The score chart is provided below.

VLB Initiatives:

- Construction work at the Rio Grande Valley State Veterans Cemetery in Mission has commenced. This project will replace both the Administration Building roof and the Committal Shelter roof, integrate Space Force, install automatic gates, install a big, beautiful Texas star in the assembly area and execute some repairs. This project should be completed by March 2026.
- Work continues on an online donations capability for the Vet Homes and Cemeteries. This
 improvement will allow anyone to donate by simply filling out information on a webpage and
 entering their credit card information instead of having to follow the current paper-based
 methodology. It is predicted that this simple step will result in significantly increased
 donations. Picture of the interface concept is provided below.
- The donation of 64 acres by a private citizen for the purpose of constructing a Texas State Veterans Cemetery in east Texas is nearing completion. Once completed, the landowner will attend a VLB Board meeting to be recognized by this body.

Other Items of Interest:

- Gate hours were changed on 1 October and all cemeteries now close at 6:00 pm due to shorter daylight hours. We will return to closure at 8 pm in the Spring.
- As is now tradition, our front gates will be lit green to observe Operation Green Light for Veterans beginning just before Veterans Day and will remain in place throughout the holiday season.
- There will be various activities and events at the Texas State Veterans Cemeteries for Veterans
 Day, all focused on the placement of flags on every headstone. Details are available on social
 media for each cemetery.







Subject: Agenda Item 10 a – Report on State Veterans Home Operations.

Recommendation: This agenda item requires no action from the Board.

The Texas State Veterans Home program was authorized in 1997, when the Texas Legislature passed Senate Bill 1060, creating the program to provide long-term care for veterans, their spouses, and Gold Star parents. The VLB owns 10 skilled nursing homes with a capacity of 1,420 residents.

Census:

The Texas State Veterans Home Division will end FY25 with an average overall annual census of 96.5%.

Home Updates:

The Tuskegee Airmen TSVH in Fort Worth is officially certified by Health Human Services and the Veterans Administration. Currently, the census is 63 out of 120 with a goal of 5 admissions per week to reach 90% by mid-December 2025.

Three contracts were negotiated and renewed (El Paso, Tyler, Bonham) for an additional 3-year period with a contract expiration date of April 30, 2028. These homes are operated by HMR VSI.

Three contracts were negotiated and renewed (Floresville, Big Spring, McAllen) for an additional 3-year period with a contract expiration date of Aug 31, 2028. These homes are operated by Touchstone Communities.

Temple TSVH was placed up for public solicitation and STGI won the contract. On September 1, 2025, STGI assumed operations of the Temple Community for a 3-year period.

Amarillo is currently in the second year of a three-year contract. HMR VSI is the operator.

Houston was negotiated and will be renewed in January 2026 for an additional three years. HMR VSI is the current operator.

Subject: Agenda Item 10 b – FY25 annual report on collaboration with Texas Veterans Commission on assisting Texas State Veterans Home Residents with VA Disability Claims.

Recommendation: This agenda item requires no action from the Board.

During FY25 the Texas State Veterans Homes staff have worked closely with the Texas Veterans Commission (TVC) Claim Specialists to streamline the process for assisting residents in filing and pursuing VA disability claims. This partnership has resulted in improved communication between facility staff and TVC representatives, leading to more timely claim submissions and better support for our residents throughout the process.

The table in the supporting document shows the FY24 results and the FY25 results. The FY25 results show that the teamwork between the two teams has provided great outcome for our veterans that are residents of our Texas State Veterans Homes.

In FY25 the joint efforts on behalf of the veterans results in:

- 384 VA claims submitted to the VA.
- 43 Veterans receiving approval for first time claims.
- 45 Veterans were upgraded from an existing disability rating to above 70% serviceconnected disability rating.
 - o These Veterans now live in the homes at no cost to them.
 - These Veterans received retroactive payments directly to them from the submission date of their claim.
 - These Veterans now receive a higher monthly disability payment form the VA which they get to keep.
- The VLB received retroactive payments from the VA in the amount of \$3,688,244.78.

Subject: Agenda Item 10 c – Consideration and possible action to designate Bexar County as the location of a Texas State Veterans Home and delegation of authority to the Executive Secretary to accept a suitable donation of land for that purpose.

Recommendation: Staff recommends approval to designate a location in Bexar County as the site for future Texas State Veterans Home contingent upon a land donation and to delegate authority to the Executive Secretary to accept a land donation if the land is deemed suitable for that purpose.

The VLB owns 10 skilled nursing homes for Veterans, their spouses, and Gold Star parents, offering shelter, food, medical care, and social activities. Locations include Amarillo, Big Spring, Bonham, El Paso, Floresville, Fort Worth, Houston, McAllen, Temple, and Tyler.

The homes are built in collaboration with the U.S. Department of Veterans Affairs, which helps partially fund construction and health benefits. Through its partnership with the VA, the VLB applies for grants and manages the grant process, design and construction. The VA funds 65% of construction costs, while the VLB is responsible for securing the remaining 35%. The VLB maintains full ownership of the home.

Bexar County is considering donating 27 acres of land near US 90 and Loop 1604. Bexar County is a prime candidate for a Texas State Veterans Home. The number of living veterans is among the highest in the country and demand for state veteran home services in Texas is high. VLB staff believes that this proposed location will be successful and serve the target audience that these homes are meant to serve.

In accordance with the Texas Natural Resources Code and board rule 110.30 (E), the board determines, "resident capacity, location and name of Veterans Homes and Veterans Cemeteries¹."




Figure 1. Proposed 27 AC site in western Bexar County.

The proposed site meets the requirements under state and federal law and has a likelihood of qualifying for a federal grant under VA rules. Texas Natural Resources Code Sec. 164.0051. states:

LOCATION OF VETERANS HOMES. To the extent practicable, when determining the location of new veterans homes in this state, the board shall consider:

- (1) the geographic proximity to existing state veterans homes with special regard to areas not served by state veterans homes;
- (2) the economic impact of the veterans home on the local community and the veterans program; and
- (3) the areas with a significant veteran population, without regard to international boundaries.

To qualify for federal construction grant funding from the Department of Veterans Affairs the proposed site must meet the requirements of 38 Code of Federal Regulations (CFR) Part §59.30. Staff assesses that the site is likely to meet all requirements.

Next Steps

If the Board approves this agenda item, the staff will initiate a Phase I Environmental Site Assessment (ESA). An ESA is a preliminary investigation that provides a baseline understanding of a property's environmental condition to identify potential environmental liabilities before a real estate transaction. It involves a non-intrusive process of historical record review, a physical site inspection, and interviews with people knowledgeable about the property. The goal is to identify any recognized environmental conditions, which are hazardous substances or petroleum products that may be present.

Concurrent to the ESA the staff will consult with the VA and draft a donation agreement with Bexar County.

Timeline

The lifecycle of constructing a new state veterans home is extensive and requires collaboration between local, state and federal authorities. A general timeline is listed here. This timeline is based upon experience from the construction of the Houston and Fort Worth homes. This timeline does not include securing VA grant funding which is dependent on sufficient appropriations from the U.S. Congress.

Timeline for Construction and Opening

(Average duration)

- Discuss project potential with the VA grant representatives 2 months
- Secure land transfer to VLB/GLO, required for VA grant 4 months
- Select Architect/Engineering (A/E) firm and issue work order 2 months
- VA required site analysis and environmental review, including mandatory public postings and federal agency approvals - 3 months
- Preliminary design, budget and VA documentation 3 months
- Submit preliminary VA grant package annually August deadline
- VA issues preliminary funding priority list December
- If awarded, complete A/E construction documents VA forms 6 months
- Procurement and project bidding (following State / GLO Procurement rules) 3 months
- VA approval and award letter issued 2 months
- Construction contract and pre-construction requirements 2 months
- Construction phase approximately 17 months (market dependent)
- Furniture, fixtures and equipment installation 3 months
- Hire contracted operator, staff, complete VA and State HHSC inspections 3 months
- Phased admittance with interim HHSC inspections 2 months
- Full occupancy and operation begins Estimated Total duration: 52 months (4.33 years)

All contracts under \$1 million are administered by the Texas General Land Office.

The Contract Management Division (CMD) of the Texas General Land Office is responsible for managing the Board's contracts. CMD uses a Contract Lifecycle Management software for the day-to-day development and management of all contracts, including those of the Board. The development and management of the Board's contracts are administered in the same manner as GLO administered Board contracts.

CMD provides this annual report to the Board regarding the status of all Board contracts as of September 25, 2025. The attached report provides details of the Board's contracts, including:

- 37 of the Board's contracts are designated as Major Contracts; and
- 19 Major Contracts will expire during FY26 & FY27

Recommendation: This agenda item requires no action from the Board.

VLB Marketing and Outreach:

The VLB Outreach team consists of eight (8) staff members throughout the State of Texas whose role is to raise awareness of and explain how to access VLB's programs, benefits, and services to Texas Veterans, military members, family members, and supporting organizations.

In FY25, the Outreach team hosted or participated in over **890** Veterans outreach events, including benefits fairs, visits to military installations, colleges and universities, programs for land developers, presentations to Veteran Services Organizations and the long-term care community, statewide Veterans conferences, outreach to various law enforcement agencies, and other government agencies.

The Outreach team partnered with VLB-participating lenders, local Boards of REALTORS, and realty companies to offer a Texas Real Estate Commission (TREC)-approved Continuing Education Course on VLB Home and Land Loan Programs. REALTORS who complete this course earn one hour of continuing education credit. The team completed **48** TREC classes in FY25.

The Marketing and Outreach team conducted multiple radio and TV interviews and appeared on several podcasts to promote VLB programs and raise awareness of the steps necessary to access each benefit program.

The Marketing team led two paid ad campaigns to raise awareness of our Texas State Veterans Homes and increase the number of Veteran residents cared for at the homes. The team also placed ads on social media, streaming video services, and websites frequently visited by Veterans to promote the home and land loan programs. VLB Marketing hired a new Voices of Veterans Program coordinator and is expanding the program to include video interviews for distribution to a broader audience.

In partnership with the Texas Veterans Commission (TVC), the Marketing and Outreach team co-hosted the South Texas Veterans Benefits Fair in Edinburg in January 2025 and the Panhandle Veterans Expo in Canyon in June 2025. Veterans, military members, and their families were provided information and access to state, federal, and local Veterans benefits.

The Marketing and Outreach team offered semimonthly Zoom@Noon Veterans Benefits Webinars, which include a 30-minute overview presentation of VLB benefits and programs and an opportunity to ask questions at the end.

Texas Veterans Call Center:

The Veterans Land Board operates a joint Veterans Call Center with the Texas Veterans Commission (TVC). The call center, consisting of five (5) VLB staff members, is housed in the VLB in Austin and operates Monday through Friday from 7:30 A.M. to 5:30 P.M.

The Call Center provides detailed information on VLB and TVC benefits, programs, and services. The team also serves as a resource for various other state, federal, and local benefits programs.

The Veterans Call Center answered over **54,500** calls in FY25. Approximately 20,000 (~37%) calls were answered for the Texas Veterans Commission (TVC). Most TVC calls are related to scheduling an appointment to process benefits claims.

Abandoned call rates increased from 6.9% in FY24 to 8% in FY25 due to one staff member retiring and going through the onboarding process for a new employee, and one staff member being out for medical reasons on two occasions.

Call wait times improved from 3:51 minutes in FY24 to 3:45 minutes in FY25.

Customer satisfaction remained about the same in FY25 based on feedback from callers.

Another challenge the Call Center team overcame was the transition from the FlexBooker benefits appointment scheduling software to the new WaitWell scheduling system.

Nearly 15,000 new Veterans were entered into VLB's Customer Relationship Management System.

VLB leadership will explore ways to increase the use of technology to increase Call Center efficiency beginning in FY26.

Summary

Internal Audit conducts a risk assessment of all GLO and VLB operations each year. Based on the data gathered from this assessment, an annual audit plan is formulated. Today's agenda item is to update the Board on the status of previously planned audits and inform the Board of audits scheduled for fiscal year 2026.

Last year, I sought approval to hire a contractor to audit the bond program. However, since then, the assets of the bond program have been transferred to the Texas State Treasury. Due to the significantly reduced risk for the portfolio, I concluded that an audit was unnecessary at this time. Consequently, a contract was not initiated. If my assessment changes in the future, I will come back to the Board with a recommendation.

The 2026 Audit Plan includes an audit of the Texas State Veteran Home Program's vendor management processes. The goal of this audit is to evaluate the effectiveness of the controls for the VLB's oversight and management of the TSVH Operators to ensure compliance with applicable policies, contractual requirements, and operational standards.

VLB BOND FUNDS MANAGEMENT

The VLB Bonds Fund Management team plans, executes, and manages the overall financial management strategy for VLB to maximize economic benefit and provide funding for VLB divisions in a manner that ensures their continued economic viability. They oversee all aspects of VLB bond fund, swap, and liquidity portfolios, including analysis of refunding opportunities and determination of method of execution to include, but not limited to loan sales and refunding. They maintain relationships with existing professionals and providers and work to expand the universe of eligible providers for VLB activities, approved swap counterparties and liquidity providers.

The team plans, executes, and manages all areas of new Veterans Land Board bond issuance and derivative interest rate swap transactions, including structuring, scheduling, cash flow analysis, document review, negotiation and execution of liquidity facilities, interaction with external bond counsel and financial advisors. They present to the VLB Board, the Texas Bond Review Board, and national credit rating agencies.

The Board may provide by resolution for the issuance and sale of bonds authorized by the constitution for the purpose of making loans to Veterans. The Board may use money attributable to bonds issued to provide money to pay all costs of issuance of the bonds, including costs, fees, and expenses of the board to pay from the Veterans land fund in connection with the issuance of the Veterans land bonds.

Complete Bond Portfolio Review.

Tactics: Review and assess the current loan and bond portfolio and cash flows with outside consultants including bond counsel, tax counsel, financial advisor, and arbitrage rebate consultants.

Deliverable: Recommendations on actions to current bond portfolio, future bond structures, and loan portfolio.

Results: Complete. Based on the portfolio review, VLB issued several series of bonds that removed restrictive bond covenants resulting in freeing up more than \$26M in reserve funds. This action reduced the amount of high-interest rate bonds and added additional funding capacity for both the land and housing loan programs. Bond Funds Management will continue to review the portfolio for future bond structures and adaptability to market conditions.

Objective 2

Manage bond funds in a fiscally sound way to ensure the maximum return while managing financial risk.

Tactics: Review the budget and cash flows related to bond funds to ensure sufficient revenues to fund expansions, ongoing administrative costs, and future construction costs. Work with all VLB program areas and GLO financial management to improve communication and expectations.

Deliverable: Create reports on each home and bond fund activity that project multiple scenarios based on historical activity as well as best/worst case. Increase VLB input in the budgeting process independent of GLO to ensure that budgets match with expected revenues.

Results: Complete. Bond Funds Management created a monthly financial report that shows cash activity for the Cemetery, Homes, and Loan Program, improving decision-making and improved financial management. Conducted monthly financial reviews with senior VLB leadership.

Objective 3

Maximize benefits to Veterans.

Tactics: Explore options to provide greater benefits to Veterans at our nursing homes by evaluating the cost structure and maximizing all resources available to VLB and the residents.

Deliverable: Assessment and recommendations to the Board on fiscal strengths and weaknesses to guide future decisions.

Results: Partially Complete. This is an ongoing process and will continue to be refined during FY26. VLB is exploring ways to increase its bed capacity to serve the maximum number of Veterans and will be doing a comprehensive review of pricing, cost effectiveness, and revenue projections to ensure that VLB can provide the best service and experience to the most Veterans at an affordable price.



VETERANS LAND AND HOUSING

The Veterans Land and Housing division receives, processes, originates, and closes land, housing, and home improvement loan applications. The Veterans Land Loan section gives Veterans the opportunity to borrow up to \$150,000 to purchase land at competitive interest rates with a 30-year fixed term. Dual-military and dual-Veteran married couples are eligible for land loans up to \$225,000. Sometimes the VLB must forfeit on delinquent land loans. The VLB then makes these tracts of land available initially to Texas Veterans and later the public, to purchase in Quarterly Land Sales.

The Veterans Housing Assistance Program (VHAP) aids Veterans in purchasing a home. Eligible Texas Veterans have an opportunity to purchase a home with a competitive, low-interest loan with little or no down-payment. Veterans with a VA service-connected disability rating of 30% or greater qualify for a discounted interest rate.

The Veterans Home Improvement Program provides loans to qualified Veterans for home repairs and improvement to their existing homes.

Assist Veterans in purchasing or processing of homes, land and home improvement loans.

Tactics: Collaborate with VLB Marketing & Gateway Bank (Program Administrator) in promoting all loan programs to increase participation.

Deliverable: For Fiscal Year 2025, purchase from participating lenders, VHAP loans in the amount of \$400M to \$500M, originate and fund \$80M to \$100M in land loans and \$2M to \$3M in home improvement loans. Maintain buyer's loan solvency through loss mitigation efforts that achieve no less than 65% of delinquent land accounts removed from forfeiture. Reduce loan processing time to less than 45 days.

Results: Partially Complete.

Home Loans target: \$400M to \$500M.

• Actual: \$385M (96% of target)

Land loans target: \$80M to \$100M.

• Actual \$76.8M (95% of target)

Home Improvement loan target: \$2M to \$3M.

Actual: \$2.2M (on target)

Delinquency target: no less than 65% of delinquent land accounts removed from forfeiture.

• Actual: 82% of delinquent loans removed from forfeiture.

Loan processing time target: Reduce loan processing time to less than 45 days.

Actual: loan processing time reduced to 44 days.

Objective 2

Implement and promote the dual spouse participation in the land program.

Tactics: Collaborate with VLB Marketing to promote the dual spouse program.

Deliverable: Implement and promote dual spouse participation.

Results: Complete. On July 30th, 2024, the Board approved the dual spouse loan program. VLB began accepting applications in November 2024. A press release was published on November 5, 2024, communicating the availability and benefits of the program.

Outreach materials were updated to include information regarding the dual spouse program. A digital marketing campaign was launched promoting the expanded benefit.


In FY25 a total of 13 dual spouse loans were closed, with a total value of approximately \$2.5 million. This represents 2.8% of total land loan value in FY25.

Improve customer service via self-help online system for the land and home improvement loan programs.

Tactics: Work with Information Technology Services and MeridianLink to implement an online system where applicants may view the status of their loan application and view any outstanding deficiencies and next steps.

Deliverable: Implement an online system using the current loan origination system, where applicants can obtain up to date status of their loan application.

Results: Not complete. Staff is working with MeridianLink in FY26 to explore potential solutions.





TEXAS STATE VETERANS HOMES

The VLB owns ten skilled nursing homes that provide shelter, food, medical attention, nursing services, medical services, social activities, or other personal services or attention to Veterans, their spouses and Gold Star parents. As of 2025, the existing Veterans homes are in Amarillo, Big Spring, Bonham, El Paso, Floresville, Fort Worth, Houston, McAllen, Temple, and Tyler.

The VLB contracts with private nursing home companies for day-to-day operations and maintenance of the homes. Each facility is designed to enhance quality of life with a clean, caring, and dignified setting appropriate to those men and women who have served our country with honor.

The Texas State Veterans Homes are constructed and operated in partnership with the United States Department of Veterans Affairs which provides partial funding for construction, expansion, and health care benefits. Residents can combine private insurance, VA payments and Medicare or Medicaid to cover daily costs. Eligible Veterans with a service-connected disability of 70% or greater may stay at the homes at no cost to the Veteran. Residents can choose between a private or semi-private room based upon availability. Memory care units at each home provide highly specialized care including access to secure landscaped courtyards.

Complete construction, open and admit the maximum number of Veterans and eligible family members as residents in the Tuskegee Airmen Texas State Veterans Home in Fort Worth.

Tactics: Follow procedures and admit Veterans and pass all inspections. Admit our first Veteran resident in Q2 FY25.

Deliverable: Home will be 90% full by 4th quarter of FY25.

Results: Partially complete. Grand Opening was March 5, 2025. July 25, 2025, the home passed all certifications and was opened to admissions. The certification was delayed due to construction issues. This delay pushed back the VA certification by two months. At the end of 4th quarter FY25 the home was 40% full (48 admitted out of 120 maximum).

Objective 2

Maximize the usage of the VA Nurse Grants Program

Tactics: Track monthly operator utilization of the nurse grant program. Discuss utilization at regular intervals with operator leadership.

Deliverable: Utilize 90% or more of available grants during the fiscal year.

Results: Partially completed. Touchstone utilized 100% of their allotted Nurse Grants in FY25. HMR utilized 52% of their allotted Nurse Grants in FY25. The FY25 utilization rate is the highest since inception of the grants four years ago.

Objective 3

Enhance living conditions for Veterans and residents in Texas State Veterans Homes that are 20 years or older (Amarillo, Big Spring, Floresville, Temple) by planning and beginning execution of a refurbishment and remodeling plan.

Tactics: Work with the Refurbish Team established in FY24 and develop a plan and grant application to the VA to refurbish the four homes that are 20+ years of age.

Deliverable: Submit a grant application in accordance with VA established guidelines. If a grant is awarded in FY25, begin execution of renovations.

Results: Partially complete. VA Grant submitted by the April 15, 2025, federal deadline. The VA did not approve the VA grants for FY26. Application will roll-over and be considered for federal FY27.

Establish in person peer-to-peer counseling in each home.

Tactics: Provide professional, standardized Post Traumatic Stress Disorder (PTSD) training. Outsource the training if necessary. Establish Memorandum of Understanding with the Texas Veterans Commission to facilitate collaboration.

Deliverable: Provide military competency focused training for the staff of all operators to ensure proper care and approach is used when caring for Veterans and residents with PTSD.

Results: Complete. Collaborated and partnered with the Mental Health Department of Texas Veterans Commission (TVC) to send training teams out to each community. TVC trained on two major topics: basic miliary competency, such as not calling a Marine a Soldier and caring for residents with Post Traumatic Stress Disorder (PTSD).

Objective 5

Collaborate with the Texas Veterans Commission to review the disability claims of resident Veterans with the U.S. Department of Veterans Affairs.

Tactics: Ensure benefit packets are current and processed through the VA system to ensure Veterans are receiving the benefits that they have earned. Provide space, times and locations for TVC representatives to visit each home on a regular basis. Track TVC claims specialist visits and interactions with residents.

Deliverable: Increase the number of 70% Service-Connected Disabled (SCD70) Veteran residents by at least 20% more by year-end FY25.

Results: Partially complete. Increased SCD70 Veterans by 17.3% in FY25 resulting in \$3,688,224 in retroactive payments to the VLB. Conducted 93 TVC visits. Assisted 43 Veterans with successful first-time claims and assisted an additional 45 veterans to increase their existing disability rating above 70%.

Objective 6

Serve the maximum number of Veterans by maintaining a daily population of 92% or greater in all Texas State Veterans Homes.

Tactics: Maintain a clean, caring, and dignified environment for our Veterans, their Spouses, and Gold Star Parents. Collaborate with our operators, the Texas Health and Human Services Commission, and the U.S. Department of Veterans Affairs to identify and resolve issues impacting resident quality of life.

Deliverable: Average census above 92% across all homes for all twelve months of the fiscal year.

Results: Complete. Maintained a 96.5% average census FY25.



TEXAS STATE VETERANS CEMETERIES

The mission of the Texas State Veterans Cemeteries is to serve eligible Veterans and their families by providing high quality support for committal services and perpetual care of the grounds and facilities for all who served our nation with distinction.

The VLB operates four Veterans cemeteries located in Abilene, Corpus Christi, Killeen, and Mission. A fifth cemetery is under construction in Lubbock with completion scheduled for late calendar year 2025. The cemetery division is a partnership between the VLB and the U.S. Department of Veterans Affairs. The state cemeteries are strategically located to complement the five national cemeteries in San Antonio (2), Houston, Dallas-Fort Worth, and El Paso.

At each cemetery, VLB interests are monitored by an on-site representative who is an employee of the agency. Daily operations and maintenance are conducted via contracts with county or municipal governments. The state provides this benefit to Veterans in recognition of their service to this state and the United States and to honor Veterans with a final resting place and with lasting memorials that commemorate their service.

Successfully implement the Lubbock establishment grant (TX-22-34).

Tactics: Develop and manage monthly reports across constructing, equipping, staffing, and training work strands to identify and correct coordination and planning issues. periodic on-site visits. OSR monitors closely.

Deliverable: Meet all project timelines, no cost overruns.

Results: Complete. At the end of FY25, construction is 86% complete and is on schedule and on budget. Three personnel are hired by the City of Lubbock and have attended numerous training events at the cemetery in Abilene. The balance of the 9-person staff will be hired in October 2025. All major equipment is in storage in Lubbock awaiting building hand-over.

Objective 2

Successfully implement Corpus Christi expansion grant (TX-22-33).

Tactics: Develop and manage monthly reports of construction progress and operational impacts. Periodic on-site visits. OSR monitors closely.

Deliverable: Meet all project timelines, no cost overruns.

Results: Complete.

Objective 3

Successfully implement Killeen expansion grant (TX-23-35).

Tactics: Develop and manage monthly reports of construction progress and operational impacts once NCA grant is awarded.

Deliverable: Meet all project timelines, no cost overruns.

Results: Complete.

Implement a local government support contract at the West Texas State Veterans Cemetery in Lubbock.

Tactics: Draft and negotiate a support contract to provide the personnel and daily operating supplies for the cemetery.

Deliverable: 100% local support contract in effect by end of FY25.

Results: Complete. Executed a 5-year contract with City of Lubbock.

Objective 5

Recommend changes to the Texas Natural Resources Code to reflect the modern realities of the cemetery program.

Tactics: Provide information and subject matter expert testimony, as requested, for the Legislative Session." Replace current Deliverable with "Timely and accurate staff support of the Government Affairs Team.

Deliverable: Timely and accurate staff support of the Government Affairs Team.

Results: Complete. Legislature passed a bill to eliminate the 7-cemetery limit and the \$7 million budget limit.

Objective 6

Develop, prepare, and submit establishment grant applications for new cemetery locations in Texas.

Tactics: As identified and directed, prepare engineering estimates and submit establishment grant applications.

Deliverable: Establishment grant applications submitted for new cemeteries in Texas which are fully conforming to NCA submission standards and submitted by 1 July.

Results: Complete. Submitted an establishment grant for east Texas on June 22, 2025.



VETERANS AFFAIRS

Veterans Affairs is responsible for assessing how all actions within the Veterans Land Board impact our Veterans. Veterans Affairs supervises the Pharmacy Audit program in support of our State Veterans Homes and the VLB Accounting Team in support of our State Veterans Homes and State Veterans Cemeteries. The Team is led by the Assistant Executive Secretary who serves as a key leader and advisor to the Executive Secretary. The Assistant Executive Secretary has the authority to lead the agency in the absence of the Executive Secretary.

Develop a consolidated complaint tracking system for all VLB divisions.

Tactics: Review current complaint tracking efforts in VLB divisions. Identify existing commonalities, critical information required by each, and create a single, shared template that conforms to Sunset Commission recommendations and helps organize and streamline complaint tracking and resolution.

Deliverable: Functional VLB-wide complaint tracking system that can produce quarterly and annual executive level dashboards by March 2025.

Results: Complete. Objective completed in April 2025. In collaboration with Information Technology Services (ITS), we developed standardized complaint tracking documents for each VLB division. These trackers are linked to the web-based complaint form on the VLB website and are filled automatically when a complaint is entered. Division representatives can manually enter complaints received outside of the web form. All division trackers roll up to one master tracker at VLB executive level.

Objective 2

Establish single source Texas State Veteran Homes census report.

Tactics: Eliminate redundant work in the creation and use of the current census report. Explore potential of using PointClickCare (PCC) software to generate this report from existing resident data. Incorporate automated rules/processes to produce needed follow-on reports and data inputs for VLB divisions.

Deliverable: A census report, easily accessible by operators and VLB program areas, that can function as the single data source for VLB reporting and data input needs by June 2025.

Results: Partially complete. Objective still in progress and continues as a FY26 objective. Customized census report from Point Click Care (PCC) system is being coded by Primecare, a third-party IT vendor. Primecare supports both HMR/Texas VSI and Touchstone. Report is 80% complete and actively being tested by both operators.

Improve the efficiency and accuracy of the pharmacy audit database, named VLBPAS.

Tactics: Eliminate—to the greatest extent possible—manually maintained spreadsheet inputs in favor of database-of-record (e.g. PCC) reports for the monthly pharmacy audit. Work with GLO Information Technology Services (ITS) to modify the rules in VLBPAS to accurately reflect the permissions and restrictions in the Medication Ordering Guidelines.

Deliverable: Database-of-record inputs to VLBPAS by June 2025. Guidelines correctly implemented in VLBPAS by August 2025.

Results: Not complete. Revisions to the Medication Ordering Guidelines are currently ongoing and Information Technology Services (ITS) made rule adjustments in VLBPAS on an as-needed basis throughout FY25. This objective was contingent upon the completion of the automated census report from Point Click Care and will roll over into FY26.

Objective 4

Improve collaboration with Veteran community and state level Veteran Services Officer leadership.

Tactics: Establish working relationship with Texas Coalition of Veterans Organizations (TCVO). In conjunction with TCVO, TVC, and VLB Marketing, identify the Veteran communities and VSOs where VLB connection is lacking/needed and prioritize those regions and organizations. Engage those Veteran communities and organizations' leaders to identify methods to strengthen our working relationships, cooperation, and collaboration.

Deliverable: Contact established with the identified communities and leaders and actions taken / recommendations to strengthen collaboration by June 2025.

Results: Partially complete. Relationship was established with the legislative director of Texas Coalition of Veterans Organizations. Corporate-level connections were facilitated between VLB Marketing & Outreach and Veteran Employee Support Groups (ESG) at both Boeing and Wal-Mart.

Identify process improvements or technological options to gain measurable efficiencies in VLB Accounting.

Tactics: Use of DocuSign for signature approval. Elimination of double or redundant work not required for error-checking or verification. Collaboration with VLB, GLO, and external partners to identify and share best practices and lessons learned.

Deliverable: Demonstrable increase in efficiency or effectiveness.

Results: Partially complete. This is an ongoing objective within VLB Accounting and will continue in FY26. Collaborated with Information Technology Services (ITS) and Office of Information Security (OIS) to establish a HIPAA-compliant, secure file-sharing platform for Veterans Home Operators to submit invoices for approval. This improved the information security environment and eliminated the problematic method of transferring these invoices via email.



Other Accomplishments

Pharmacy Auditor

- Completed 12 monthly pharmacy audits of ~150,000 records totaling more than \$5.5M with no significant findings—ensuring our Veterans Homes Operators are complying with their pharmaceutical contractual requirements.
- Completed quarterly price audits of the VLB pharmacy vendor, Omnicare, with no significant findings—ensuring Omnicare maintains their contractually-agreed pricing model.
- Initiated a Trust Account audit process at Veterans Homes in the off-year that Texas Health and Human Services Commission (HHSC) conducts their bi-annual Trust Account audit. Doing so provides VLB visibility of Operators' efforts to comply with Texas Administrative Code (TAC) 554.404 and 554.405 prior to HHSC's audits. To date, Floresville, Houston, and Tyler audits have been completed. All comply.

VLB Accounting

- Over a two-month span from December 2024 to January 2025, reduced a backlog of \$1.7M in pending invoices to \$0 and implemented control measures to prevent invoices going past the 30-day prompt payment requirement.
- Completed FY23 Medicaid Cost Report resulting in \$2M reimbursement to VLB from Texas Health and Human Services Commission.
- Primary resource for Texas State Veterans Homes Federal Single Audit. Facilitated documentation and process review for VA Nurse Grant and VA Per Diem programs with no issues noted. Audit ongoing into FY26.
- Processed \$3.68M in retroactive per diem payments for residents who increased their VA Service-Connected Disability rating through VLB/TVC claims update partnership.
- Identified and resolved an issue with the Rio Grande Valley Cemetery plot allowances from the VA, resulting in recoupment of \$800,000 in revenue and a process change in the State Veterans Cemetery division to prevent similar issues in the future.

Director of Veterans Affairs

- Delivered a presentation on VA-Grant-Funded Texas State Veterans Cemeteries to the Cameron County Commissioners Court and subsequently sparked the Court's interest in building a Texas State Veterans Home.
- Participated in agency-wide Storm Table-Top-Exercise to clarify roles, responsibilities, and actions for Veterans Homes and Veterans Cemeteries in concert with other agency divisions and departments in a severe weather emergency.



LEGAL COUNSEL

The General Land Office's Office of General Counsel provides legal services to the Veterans Land Board. They make available legal support that provides expertise; advice on operations; review of real estate transactions; contract negotiation, review and tracking; open records and open meetings advice; consultation on human resources matters; and drafting, review and advice on rulemaking.

General Counsel has assigned two attorneys in its General Law section to provide day-to-day support to the Executive Secretary, the leadership team, and staff. General Counsel assigns other attorneys in Legal Services to assist the Veterans Land Board on an ad hoc basis.

Objective 1

Enhanced guidance on procurement processes.

Tactics: Increased dialogue with divisions on pre-contractual requirements, contract performance issues, end dates and potential renewals, and issues involving negotiations.

Deliverable: Provide more comprehensive guidance to VLB divisions on aspects of the procurement process.

Results: Complete. Engagement on renewals and solicitations occurred, in general, relatively earlier in the procurement process. More comprehensive guidance on a wider array of contract vehicles and agreements was achieved that can be applied to future procurements.

Review of VLB rules in the Texas Administrative Code.

Tactics: Engage with VLB divisions to perform comprehensive review of the Board's rules (Texas Administrative Code, Title 40, Part 5, Chapters 175 – 178); review, and if necessary, revise, consolidate, update, and/or repeal these rules as appropriate.

Deliverable: Updated rules consistent with the Board's policies, procedures, and practices.

Results: Complete. Rule reviews were conducted for all VLB chapters in the Texas Administrative Code (40 TAC 175 – 178) and culminated with the adoption of changes in July 2025.





VLB MARKETING & OUTREACH

VLB Marketing is imbedded in the Communications Department of the General Land Office. The Director of VLB Marketing & Outreach supervises the Marketing team, the Call Center, Veterans Outreach Specialists and Outreach Customer Service. The team's priority is to ensure Veterans are aware of and know how to access the benefits they have earned. The Marketing & Outreach team has a formal memorandum of understanding with the Texas Veterans Commission to collaborate to fund and operate a statewide call center that connects Veterans with services. The team also conducts joint marketing efforts across the state with the Texas Veterans Commission.

Provide Texas Veterans, Military Members, and their families with comprehensive information and education on various VLB benefits and programs, including home loans, land loans, home improvement loans, land auctions, State Veterans Homes, and State Veterans Cemeteries. Additionally, enhance awareness of the Voices of Veterans oral history program.

Tactics: Develop a comprehensive plan that leverages diverse marketing techniques and data-driven insights to enhance awareness among Veterans, Military Members, and their families about their benefits, ensuring effective outreach and communication.

Deliverables: Meet or exceed marketing objectives established by the Texas General Land Office and Veterans Land Board Leadership Teams. Increase marketing and outreach initiatives within industries such as real estate and long-term care, while also expanding efforts to reach rural and underserved counties statewide. Develop marketing campaigns to increase the number of interviews in the Voices of Veterans oral history program. Design and implement data-driven marketing campaigns to consistently achieve a 92% overall census for the Texas State Veterans Homes program.

Results: Complete. The VLB Marketing and Outreach team hosted or participated in over 890 Veterans outreach events, including benefits fairs, visits to military installations and colleges and universities, programs for land developers, presentations to long-term care organizations, statewide Veterans conferences, outreach to various law enforcement agencies, and other government agencies. The team also conducted multiple radio and TV interviews and served as guests on several podcasts. The Marketing team led two paid ad campaigns to raise awareness of our Texas State Veterans Homes, and home and land loan programs. VLB Marketing hired a new Voices of Veterans Program coordinator and is expanding the program to include video interviews for distribution to a wider audience.

Collaborate with the Texas Veterans Commission to serve the maximum number of Veterans possible through the statewide call center.

Tactics: Supervise and manage daily operations of the Texas Veterans Call Center to ensure optimal results and customer satisfaction. Conduct regular meetings with Texas Veterans Commission leadership to review call center operations and to address any issues.

Deliverables: Achieve higher call center customer satisfaction while minimizing wait times and reducing abandoned calls. Organize cohosted Veterans Benefit Fairs in underserved populations with the Texas Veterans Commission on a quarterly basis.

Results: Partially complete.

- The Texas Veterans Land Board (VLB) Veterans Call Center answered over 54,500 calls in FY25.
- Approximately 20,000 of those calls were answered for the Texas Veterans Commission (TVC).
- Abandoned call rates went up from 6.9% in FY24 to 8% in FY25 due to one staff member retiring and going through the onboarding process for a new employee, and one staff member being out for medical reasons on two occasions.
- Call wait times improved from 3:51 minutes in FY24 to 3:45 minutes in FY25.
- Customer satisfaction remained about the same in FY25 based on feedback from callers.
- Another challenge the Call Center team overcame was the transition from the FlexBooker benefits appointment scheduling software to the new WaitWell scheduling system.
- Nearly 15,000 new Veterans were entered into VLB's Customer Relationship Management System.
- VLB and TVC co-hosted the South Texas Veterans Benefits Fair in Edinburg in January 2025 and the Panhandle Veterans Expo in Canyon in June 2025.

Elevate the awareness of Texas Real Estate Commission (TREC) approved training courses on VLB loan programs and expand the number of courses offered.

Tactics: Work with outreach representatives throughout the state to foster relationships amongst the real estate community to increase the demand for the Texas Real Estate Commission approved training courses on VLB loan programs. Create a digital and social media marketing campaign to increase awareness of the VLB's Texas Real Estate Commission approved continuing education course.

Deliverables: Increase partnerships with real estate industry associations, lenders, and other organizations. Conduct at a minimum 50 Texas Real Estate Commission approved training courses throughout the state by the end of FY25.

Results: Partially Complete. Completed 48 TREC classes in FY25.

Objective 4

Create and execute a written strategic marketing plan for the Texas State Veterans Home in Fort Worth.

Tactics: Collaborate with the Veterans Homes leadership, operator's marketing team, and outside media contractors to develop a plan to introduce the home to area Veterans.

Deliverables: Meet or exceed quarterly resident census targets developed by the Director of Texas State Veterans Homes.

Results: Partly complete. Census targets in FY25 were below target primarily due to construction related delays. Once the home was open to admission, the team collaborated with staff to attract residents to the home. Due to leadership changes on Marketing & Outreach Team, a written plan was not created. The VLB Marketing and Outreach group worked with the leadership in Texas State Veterans Homes, along with the Fort Worth VLB Onsite Representative (OSR), and the GLO Communications team to introduce and promote the new Veterans Home in Fort Worth. VLB Marketing launched a social media campaign and added a special section to their outreach presentations to raise awareness of the new home and explain how to sign up for the waiting list. The Communications team sent out press and media releases to local media about the home's opening. The OSR visited with local medical and social services facilities, VA hospitals and clinics and surrounding longterm care organizations to promote the new home and discuss the waitlist process. The home opened on March 22, 2025, with over 200 Veterans on the waiting list and only 120 available beds.



GOVERNMENTAL RELATIONS

The Governmental and Intergovernmental Relations department at the Texas General Land Office has a team that is dedicated to the Veterans Land Board. The team serves as the primary interface between the agency and the Legislature, other state agencies, the federal government, and local and regional governmental bodies. By serving as a bridge, the team ensures that the VLB's priorities are clearly articulated to the Legislature, while also ensuring a deeper understanding of the Board's mission and objectives. The team assists with drafting of the agency strategic plan that is submitted to the Legislative Budget Board, preparing for testimony for legislative and regulatory hearings, interfacing with legislative members and staff, and tracking of state and federal legislation of interest to the agency. Through these efforts, the team's commitment to the Veterans Land Board exemplifies the importance in advancing the interests of Veterans with the guarantee that their needs are prioritized at all levels of government.

Objective 1

Invite Elected Officials and their staff to visit all Texas State Veterans Homes and Cemeteries.

Tactics: Identify Members with VLB facilities in their respective districts to extend invitations and schedule visits after the 89th legislative session concludes.

Deliverable: Ensure that the target Members and staff visit the cemeteries and homes by the end of FY25.

Results: Partially complete. Facilitated visits from elected officials to 4 of the 5 Texas State Veterans Cemeteries and 5 of the 10 Texas State Veterans Homes during FY25.

Educate newly elected officials and their staff on VLB programs and services available to Texas Veterans, military members and their families.

Tactics: Identify new Members and staff to invite them to a brief VLB overview.

Deliverable: Host GLO/VLB informative overviews at the start of the 89th legislative session.

Results: Partially Complete. Met and briefed several newly elected members and their staff during our GLO 101 at the Capitol on February 2, 2025.

Objective 3

Solicit input from VLB staff on legislative proposals in preparation for the 89th legislative session in 2025.

Tactics: Develop a list of potential recommendations, rank by priority, prepare briefing documents as appropriate.

Deliverable: Detailed, written submission of prioritized legislative and budgetary recommendations submitted by the deadline established by the project lead.

Results: Complete. Formal list of legislative initiatives was created and submitted to the Chair for review and approval. Staff worked with Legislative Members and staff to successfully pass SB 2543 by Senator Hancock and Representative Hefner. SB 2543 removes the seven-cemetery limit on the maximum number of Texas State Veterans Cemeteries.





EXECUTIVE LEADERSHIP

The Board of Directors delegates to the Executive Secretary general powers and duties of the Board. The day-to-day executive management team is responsible for executing the strategies and operations of the VLB, with five key responsibilities.

Strategy Implementation

Develops and implements the strategic plans and initiatives outlined by the Board, aligning resources, and guiding the VLB towards its goals.

Team Management

Recruits, develops, and leads the talented individuals who form the backbone of the VLB, ensuring a motivated workforce and fostering a positive culture.

Stakeholder Communication

Maintains transparent and effective communication with stakeholders, including employees, customers, investors, and regulatory bodies, representing the VLB's interests and upholding its reputation.

Operational Leadership

Manages the daily operations, makes operational decisions, and oversees functional divisions to ensure efficiency, productivity, and profitability.

Financial Management

Manages the financial resources of the VLB, including budgeting, financial planning, reporting, and ensuring effective use of funds to achieve objectives.

Create a five-year long-range planning calendar for Board activities to identify future needs, trends, and challenges, and to support strategic decisions now to ensure future success and sustainability.

Tactics: Collaboration with the Loan Division and Bond Funds Management for awareness of key activities. Collaborate with scheduling and Board Members to ensure availability of key leaders.

Deliverable: Published five-year schedule of Board meetings and required annual or bi-annual reports or activities.

Results: Complete.

Objective 2

Keep Board Members informed of significant agency activities.

Tactics: Meet with Board Members prior to each board meeting. Provide bi-weekly briefings for the Chair. Provide a monthly executive summary of VLB activities. Engage Board members in community and agency events.

Deliverable: Bi-weekly Chair Update Brief provided to Chair. Monthly executive summary developed and provided to Board Members. Successful pre-board meetings with Board Members. Invitations to Board members to attend VLB related events.

Results: Complete.
