LOCAL HAZARD MITIGATIONS PROGRAM (LHMPP)

The Texas General Land Office allocated \$25,000,000 to the Local Hazard Mitigation Plans Program (LHMPP). This program provides grants ranging from \$20,000 - \$100,000 for eligible entities to develop or update local hazard mitigation plans, or as cost share for hazard mitigation planning activities funded through other federal sources. LHMPP is funded through a Community Development Block Grant for Mitigation from the U.S. Department of Housing and Urban Development. The program is accepting applications on a first-come, first-served basis and will approve eligible applications until funding is exhausted or July 2027.

Why is a hazard mitigation plan important?

- ✓ Mandatory eligibility requirement for several FEMA grant programs
- ✓ Identifies long-term strategies for risk reduction with input from stakeholders and the public
- ✓ Identifies cost-effective mitigation actions that focus resources on the greatest risks areas
- ✓ Integrates planning efforts and risk reduction with other community planning efforts
- ✓ Aligns risk reduction with other state, tribal or community objectives

Is a mitigation plan required? According to FEMA...

- ✓ An approved hazard mitigation plan is an eligibility requirement for several FEMA grant programs for grantees and subrecipients
- ✓ FEMA requires entities to submit an updated hazard mitigation plan every five years for review and approval to maintain eligibility

Every **\$1** spent on mitigation saves **\$6** on future disaster losses

Mitigation plans must include all dam risk in accordance with the requirements set forth in the Rehabilitation of High Hazard Potential Dams Grant Program Guidance. Dams owned by nonprofit organizations must be located in a jurisdiction with a FEMA-approved local or tribal mitigation plan that includes all dam risks in order to receive funds.

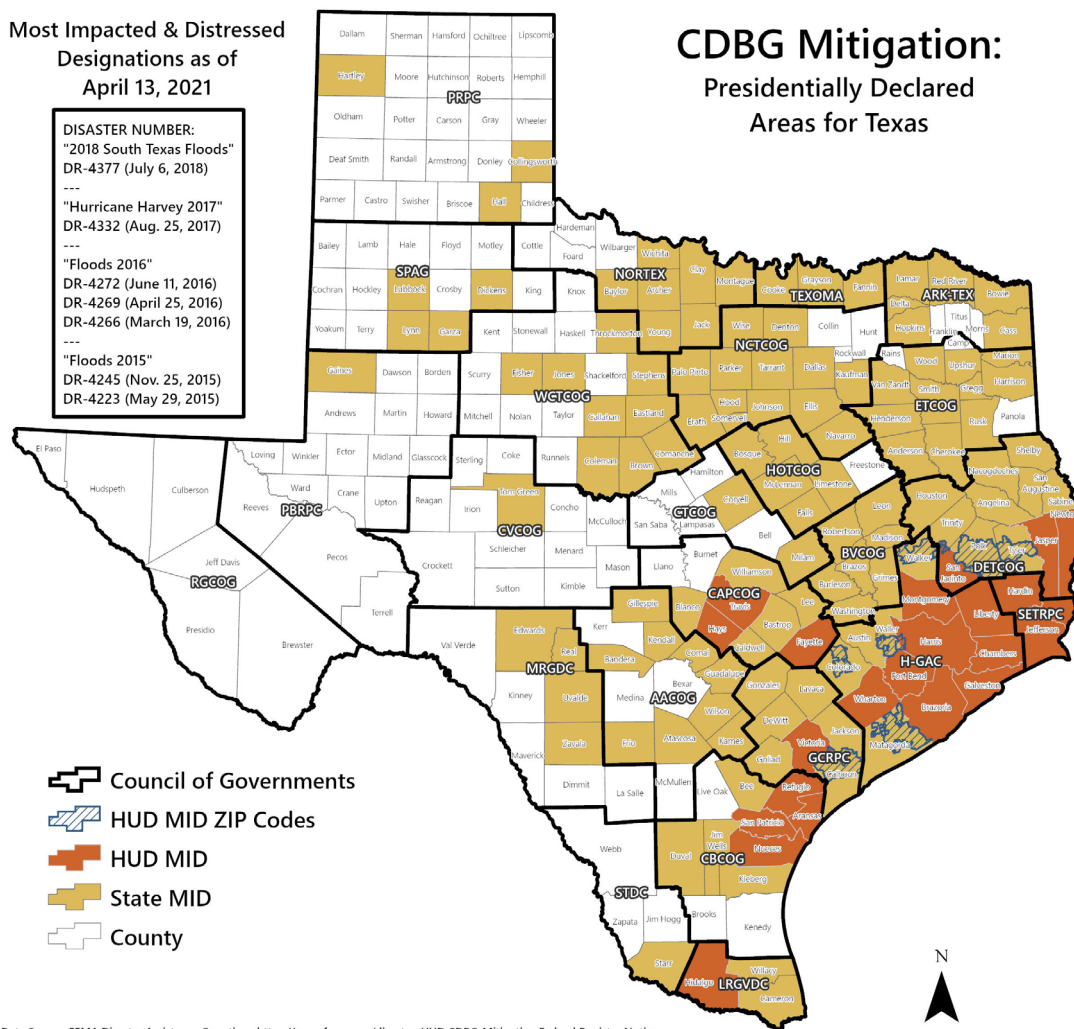

Eligible Entities

Be federally declared counties or ZIP codes from the following disasters as listed in the CDBG-MIT Action Plan Meet FEMA's definition of a local government as per 44 CFR 201.2

"Local government is any county, municipality, city, town, township, public authority, school district, special district, intrastate district, council of governments (regardless of whether the council of governments is incorporated as a nonprofit corporation under State law), regional or interstate government entity, or agency or instrumentality of a local government; any Indian tribe or authorized tribal organization, or Alaska Native village or organization; and any rural community, unincorporated town or village, or other public entity."

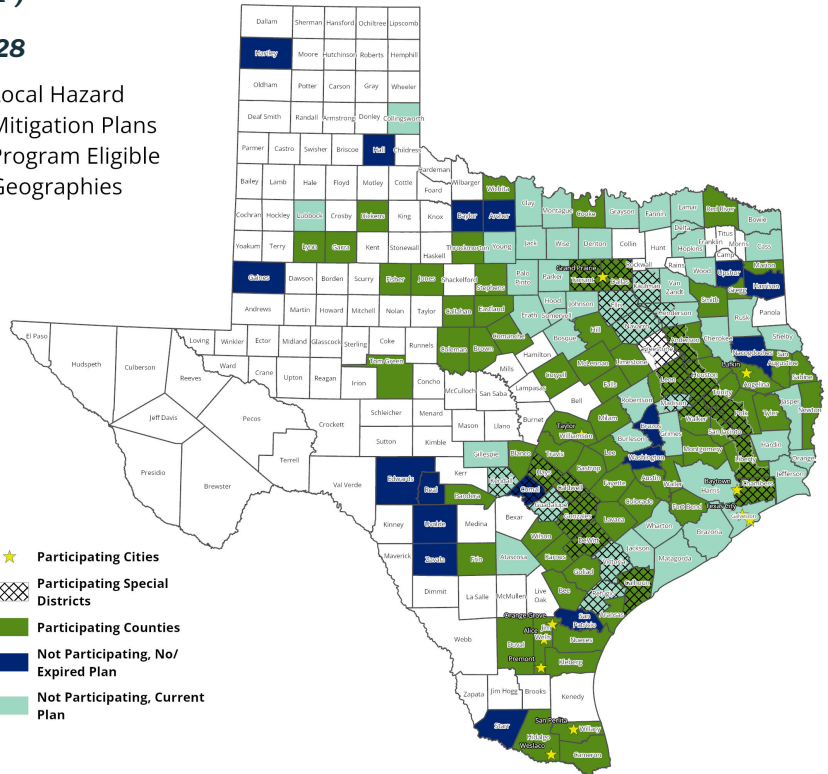
How Can We Apply for the Local Hazard Mitigation Plans Program (LHMPP)?
