- Call to fill a seat
 - Derek has stepped down as secretary, will send an email requesting a volunteer to fill the position.
- Updated rules to address absenteeism
 - O Discussed the rule change that has been on the agenda for the last couple of meetings. Margaret talked about the process: anyone who misses two meetings without notifying us will get an email asking if they still want to participate. If they don't, we'll ask for recommendations for replacements.
 - A new membership roster will be created based on the number of members who resign from the committee. Margaret reminded the attendees that state law caps the number of participants on a committee, so GLO created two to accommodate the number of volunteers. The new roster may have only one committee or two small committees.

- Program updates (see slides below)
 - o Regional Mitigation Program (COG MOD)
 - The website and list of approved projects for the MOD were posted in the chat.
 - Members had questions about future funding for this program. Margaret noted that the reallocation process hasn't been determined yet but there are several options. Discussed the setup of the Disaster

Recovery Reallocation Program (DRRP) to use CDBG-DR funds from earlier grants and the MOD reallocation process from Harvey using the already approved MOD. Said regardless of structure, the end goal is to use all recovery money in impacted communities.

- o Local Hazard Mitigation Plan
 - Members discussed concerns for colonias in counties that are not current on their hazard mitigation plan (HMP). Margaret talked about the eligible areas for the program and mentioned the Texas Department of Agriculture (TDA) has a colonias study ongoing.
- o Resilient Communities
 - Members were interested in learning about opportunities for funding through Resilient Communities Program (RCP). Jet said the program was developed to fit a FEMA plan to get credits for Community Ratings System (CRS) for the National Flood Insurance Program (NFIP). Discussion about resiliency efforts in CAC member areas; Margaret will forward emails from FEMA that may be useful.
