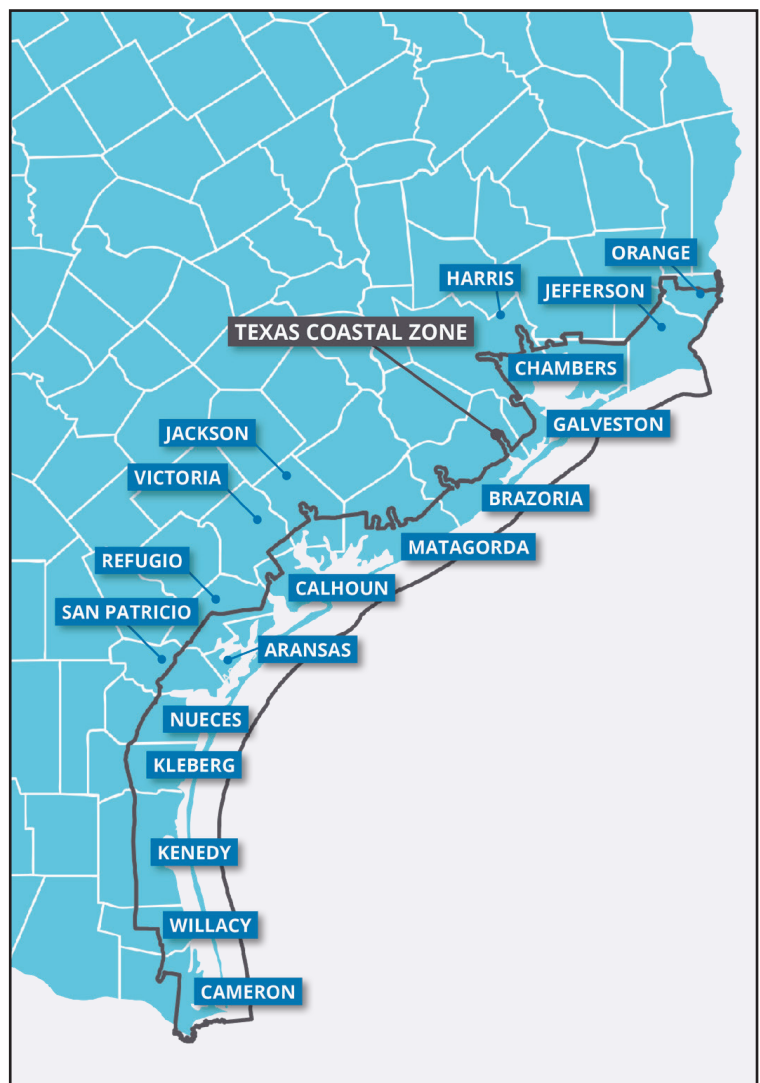
Services
