This training will provide the basic framework of the related procedural requirements of each in an Environmental Review Record and provide guidance on achieving compliance with examples.

September 24, 2024: Revisions to Part 55 and Other Related Laws and Authorities

A training session on Federal Flood Risk Management Standard (FFRMS) and recent updates to 24 CFR Part 55 and 24 CFR Part 58. This session will provide critical insights into the latest regulatory changes affecting Floodplain Management and Protection of Wetlands.

August 20, 2024: Section 106 Compliance for HUD-Assisted Projects

Section 106 compliance under the National Historic Preservation Act is required for all HUD environmental reviews for CEST- and EA-level projects. The GLO Environmental Oversight team will provide an overview of the Section 106 process with our guest, the Texas Historical Commission (THC). This training will examine the four-step review process and provide guidance on achieving compliance under 24 CFR 58. The team will also discuss consultation requirements and the required documentation/information for the submission to the electronic THC Review and Compliance (eTRAC) system to help streamline project reviews.
