The GLO is required to verify the legal status of all property owners/applicants and household members participating in the Program to prevent any federal public benefit from being provided to ineligible immigrants who entered the United States illegally or are otherwise unlawfully present in the country. Each property owner/applicant and household member (or their authorized representative, if household member/owner is incapacitated or otherwise unable to complete the form) must sign and submit this form, stating their legal status and listing the documentation they will provide to substantiate their legal status. The refusal or inability to complete this form by or for a property owner/applicant or household member may result in the household's ineligibility under the Program. The GLO is also required to verify the identity of all property owners/applicants and household members participating in the Program. Each property owner/applicant and household member (or their authorized representative, if household member/owner is incapacitated or otherwise unable to provide documentation) must provide documentation of their identity to one of the GLO's Regional Offices on or before the pre-construction conference or reimbursement signing event. The GLO may arrange home visits to verify the identity of homebound property owners/applicants and household members. NOTICE: Pursuant to HUD Memorandum 25-03 (March 31, 2025) revisions to 90 Fed. Reg. 1754, the GLO will attempt to verify the legal status of the property owner/applicant or household member named in this form through the Systematic Alien Verification for Entitlements (SAVE) system operated by the U.S. Citizenship and Immigration Services Verification Division of the Department of Homeland Security (DHS-USCIS). Additional information other than the documentation listed below for the named property owner/applicant or household member may be required to complete the verification and must be provided to the GLO upon request. The GLO is not responsible for any action taken by DHS-USCIS due to verification of legal status using the SAVE system.

I consent to the GLO's use of the information and documentation provided regarding the identity and legal status of the named property owner/applicant or household member for such verifications. I further understand that providing false representations herein constitutes an act of fraud and that submitting false, misleading, or incomplete information may result in the Project household's ineligibility to participate in the Program.
