Award Description	To restore approximately 328 acres of estuarine wetland habitat in shallow bay waters of West Galveston Bay, Texas, at two locations: Carancahua Cove and Jumbile Cove. The restoration will use sediment dredged from the bay bottom and placed in areas designed to raise the elevation of the bay bottom to a point suitable for planting of transplanted wetland vegetation. The measure for project success will be the project achieving and maintaining specified elevations and percent vegetation coverage of the habitat features, followed by a post-project monitoring of the growth and colonization of transplanted vegetation for compliance to pre-determined success criteria.
